Greetings Comrades!

We hope your year is going well so far, and you are staying up on your year-toyear tasks. The HQ team had a busy but enjoyable time in Louisville for National Convention, participating and observing the business of our National organization. We'd like to talk about a few items this time.

• First are quarterly audits. If a Post owns property and/or operates a Canteen, the Operations section must be filled out. If a Post operates a Canteen, the Post Canteen or Club Fund information in the Funds section must also be filled out. We are using the Post's Election report to determine if property is owned and if there is a Canteen. This is not a new requirement. The Operations Section has been a part of the Audit for many years. The amount of liability insurance also must be reported. If the Operations Section is not filled out, if applicable, the audit will not be accepted and returned to the Post to complete the audit.

• Next, your 990, which is required to maintain your Post's nonprofit status. Once you have filed your 990, please send proof of IRS ACCEPTANCE to HQ. Your 990-filing status will not be updated until we have a copy of the Acceptance letter.

• Regarding Bonds: if you are not going through the State (Wisconsin VFW) to get your Bond, ensure you are getting a **Surety Bond** and you must send proof of Bonding to State Headquarters.

Finally, the new online Rosters are in the **Members Only Section** of the State Website. There is a listing with Post Commanders and Quartermasters; a listing with Post Information (meeting dates, time and addresses); and a listing of Department Officers and Chairmen.

We'd also like to remind you all to please take our State Convention survey. [See info elsewhere on this page.] Your feedback is appreciated. As always, if you have any questions, don't hesitate to reach out to us!

In my last article, I provided an update regarding which State Bylaw Amendments and National Bylaw Amendments were passed during the Department Convention. Last month, during the National VFW Convention, I had the opportunity to participate in the National Bylaw, Manual of Procedure and Ritual Amendments Committee, which reviewed 40 proposed changes, including the two recommended for approval at our Convention.

Six of the 40 proposed changes were recommended by the Committee, with four being adopted by the Convention body. It was an amazing process to be part of, especially when one of the six recommended Bylaw changes went to a roll call vote, the first in approximately 29 years, and was soundly defeated by the Convention body. I want to give a shout-out to our Department Adjutant Adam Wallace, for organizing the coalition of delegates who forced the roll call vote. This is noteworthy because it shows that our voice as a Department, District or Post impacts the direction of the VFW.

Of the two proposed National Bylaw Amendments (NBA) passed at our Convention, one was adopted and will be updated in the 2025 Podium Edition VFW Congressional Charter, Bylaws, Manual of Procedure and Ritual. I want to commend the Burnett County VFW Post 1256, for bringing for-

Comrade Quartermasters:

Technically, it's "tax time" again for VFW Posts and Auxiliaries. Please save your sanity and keep your stress level low and get your IRS 990s filed. If your fiscal year ended December 31, you should have filed before May 15 and if your year ended June 30 you can procrastinate until November 15. If your gross revenue (total monies you've received) for the year is less than \$50,000, filing should be a snap. However, maybe one thing you didn't know, is that even if your gross receipts are more than the maximum,



you can average the last three years and hopefully a smaller total appears.

In addition, there may be a few other ways to reduce gross revenue to stay under the \$50K amount. I actually read part of a 49-page instruction manual (boring!) on completing the IRS 990EZ form and noted that receipts that do not benefit the Post might not need to be included in gross revenue. Two examples may include: The portion of annual dues the Post collects but passes along to National/Department and State Raffle monies we collect and forward to the Department. These funds pass through the Post's financial accounts and look like revenue but don't directly benefit the Post. Also, if you sell your Post home, there may be a cash windfall exemption for the Post as well. I could hardly believe that I learned something from reading portions of the IRS instructions (yikes!). Note that I am not an expert in these matters, so if you find yourself with excessive revenue that forces you into more complicated reporting, talk to a professional to see if there is some financial wiggle room available.

Posts should also note that the Quartermaster bonding period begins again on September 1. Likely the least expensive bond available is through the VFW and when you bond that way there is little doubt at HQ that you are bonded. Private bonding is also acceptable, but it should be in force for the same period of time, i.e. September through August. The bonding level needs to include all liquid assets like CDs and most investments. State Quartermaster Tom Heath has indicated that a short grace period is allowed for renewals but it's highly recommended to get it done before September 1.

Lastly, annual Post inspections are starting so show off for your Inspector and have everything they need at hand when they arrive. You'll feel good because you did a great job preparing and your Inspector will be pleased with a smooth and complete audit. An Inspection Checklist is available on the State website (vfwwi.org), under District Manuals and Forms. Being prepared will lower your stress level and improve your mental health. Maybe that's why Mary Ann put a Quartermaster's Checklist on page one of her Commander's Program Book. Thank you Mary Ann, for thinking of us!

Fellow Comrades,

May the Lord be with you at this moment and with your family. Hope the summer has been a good one and we are ready for the beautiful fall in Wisconsin, but not yet! I was elected for another year and I want to thank each of you that were part of that, your Posts and your Districts for supporting me. Thank you.

In the next couple of months we have our elections for this great country of ours. This may stir our faith, tempt us to say and do things that can be out of character, but let's stand firm Comrades! Greetings Comrades!

My name is Wayne Georgeson, your State Surgeon for the 2024-2025 command year. I am humbled and honored to be given the opportunity to serve my fellow comrades on the Department level. I am forever grateful to have known Mary Ann Christopherson and did not hesitate to say YES when she asked me to serve as Surgeon for her command year. Under the leadership of Commander Ron Ramos, her legacy and mission will carry on.



While I know many of you, there are even more I have not had the pleasure of getting to know yet. I am new to the State leadership

team and would like to take this time to introduce myself. I was born and raised in Central Wisconsin where I now live with my wife, Jamie, and daughters, Alexis and Alaena. My family centered around military service with one grandfather serving in the U.S. Army during the Korean War, and another grandfather serving in the U.S. Navy during WWII. Following in the footsteps of my grandparents' service, I joined the Wisconsin Army National Guard from 2007-2011, earning the rank of Sergeant, serving as an Ammunition Specialist in the Ordnance Corps and as a Military Police Officer in Detainee Operations, earning my eligibility for the VFW during deployment to Camp Bucca, Iraq, from 2009-2010.

Joining the VFW in 2019, I signed up at my hometown VFW, Post 1916 in Reedsburg. There, I served three terms as Post Commander from 2021-2024, leading our Post to earn All-State recognition in 2023-2024. On the District 11 level, I am currently the Sr. Vice Commander.

On the civilian side, my wife Jamie and I are small business owners, operating a Health Insurance Agency in Reedsburg. Prior to this, I had the privilege of serving for 11 years with the Wisconsin Department of Transportation, as the State Commercial Driver License Coordinator, Wisconsin Driver Training School Coordinator, and Lead Commercial Driver License Auditor.

For the 2024-2025 command year, I would like to continue on with Mary Ann's mission of recognizing and openly talking about mental health issues in our Veterans community. As Veterans, this is something we can all relate to as we all know someone that PTSD has touched in someway. PTSD does not just affect the Veteran, it affects us all. From the wife or husband at home that may wonder why you are quiet that night, or the son, daughter, niece, or nephew that wonders why you got so angry at something so small. PTSD affects us all.

This is also a personal issue for myself, struggling with PTSD and the accompanying depression for many years. Like many Veterans, I had to come to the conclusion myself that the only way I could overcome this was to talk about it, get out of my shell, and fight back. While we all have our own ways of working through this complex disorder, it is my goal to bring you tools and resources to add to your toolbox.

Recognizing PTSD is the first step in the treatment of PTSD. While this may seem obvious to some of us, it is easily denied by saying "I am just cranky" or "I only drink socially." It is important to openly recognize and identify these signs. The signs can be obvious or



subtle, and can gradually build up or come out of nowhere. So, let's openly talk about that first step in this article.

1. Recognizing the physical changes: These may include the Veteran having difficulty staying or falling asleep; irritability or outbursts of anger; physical reactions when exposed to internal or external cues or reminders of the traumatic event such as certain sounds or smells.

2. Recognizing the mental changes: These may include the Veteran having recurring and intrusive thoughts about the event; recurring and distressing dreams of the event; acting or feeling as if it the traumatic event were recurring-also known as having flashbacks; difficulty concentrating; and efforts to avoid thoughts, feeling or conversations associated with the trauma.

3. Recognizing the emotional changes: These may include the Veteran having intense distress when exposed to internal or external reminders of the event; a noticeable lack of interest or participation in important activities; feelings of detachment or estrangement from others; limited ability or inability to show affection or love; feelings of a bleak future,

overly alert and/or exaggerated response when startled.

4. Suicidal thoughts or ideation: These may include the Veteran having thoughts of suicide and they may openly share the thoughts with you. The Veteran may say things like "Maybe I should just end it." or "I wonder if anyone would find me.". These thoughts

The reason I mention this is that even though we have a State Commander who is in charge of Wisconsin and a Commander-in-Chief who is in charge of the entire VFW, they must still act in accordance with the wishes of the membership.

At the National Convention, there were many Bylaws and Resolutions that were proposed from Departments throughout the VFW. This is common every year and every year those specific Committees meet to discuss whether these should be proposed for adoption or rejection or if they are out of order and need to be sent back to Department level for review and resubmission the next year. Many of these Bylaw or Resolution changes are very common sense: to update language, fix language, or clean up certain areas, but this was a bit different.

Resolution 204 was put forth by the C-in-C to make a change to the VFW National Charter. Resolution 204 would have allowed membership into the VFW for Cold War Veterans who served in Africa, Asia, Europe, or their territorial waters from September 2, 1945 to December 26, 1991, for not less than 60 consecutive days, to deter Communist aggression or advances. This resolution was recommended by the Resolution Committee for adoption. When the time came for it to be voted on the main floor, it was resoundingly defeated by the membership. The membership spoke!

The other contentious change was to our Bylaws, in particular Section 618, Subsection #6. This covers the Commander-in-Chief's appointment of the Adjutant General, which is by far the most important appointment they make. The membership voted last year at the 124th VFW National Convention, to change the approval of the Chief's appointment from a simple majority of the Council of Admin-



istration to a two-thirds approval. This was done so that this important appointment had resounding approval and confidence. This year, C-in-C Sarmiento put forward a change to the Bylaw under B-15, to have it changed back to a simple majority vote.

I was on the Bylaw Committee and spoke against this change on the grounds that a simple majority could lead to someone being appointed that may not be qualified and if they are not performing, it still takes a two-thirds majority vote to remove them. Despite several others speaking against this change, it was still passed by the Bylaws Committee and recommended for adoption.

Once again, the membership of this great organization made their votes count. When this went to the main floor for an approval vote, our State Adjutant, Adam Wallace, called for a Roll Call vote which is something that had not been done in over a decade. There were over 8,000 votes cast and when it was completed, it was resoundingly defeated, receiving fewer than 1,000 votes of approval. The membership spoke!

Too often I hear from members that the leadership doesn't always listen to their concerns or that they feel they don't have a voice in what happens. That is quite the opposite, but if you don't attend Post and District meetings or the State Convention, it's hard for your voice to be heard. I want everyone to understand that this is a membership-driven organization. If you want your voice to be heard, or count, then show up. Much like the membership who attended the National Convention and made sure their voices were heard and counted.



Hello Comrades,

We are into a new membership year and it is time to make some big progress toward this year's 102% goal. We need a total of **23,270** members by June 30, 2025. That is 457 members over 100%.

In order to facilitate this, Posts need to be aware of what's happening with their membership. By the time you read this in mid-September, Memstats will be updated with our Life Membership numbers, and we'll be able to clearly see how much work we need to do to reach and surpass that 102% mark. One way to do this is to make sure every Annual member is paid, past July 1, 2025, especially all Post Officers. Remember: If an elected or appointed Officer's membership expires while in office, the position is declared vacant, and that member cannot hold another Officer position for the remaining VFW year. Don't lose your Officers!

Obviously, recruiting new members is important, but equally critical is the need to recover those members who have yet to renew their Annual membership. A very helpful tool is the **"Unpaid/Relocated"** list of those current VFW members who have moved into your area and can be transferred into your Post. These are members who have already recognized the value of being a VFW member and we should not simply let them walk out the back door. The list can be pulled from the National Online Membership System (OMS). Posts can also contact State HQ or me if they would like to get that list for their area.

To give you some ideas for recruiting new members, I had a nice conversation with Wisconsin's Top Recruiter for 2023-2024, Dave Zien of Post 305 in Eau Claire. He had some valuable insights, including:

• Always have a Membership Application with you because you can meet potential members **anywhere**. No matter where he is or what he is doing, Dave is proud to talk about the VFW and all it does. and is ready to explain the program benefits and cite examples of how we volunteer to help others.

• Every place is a chance to network. Dave is a member or alumnus of over 120 Veterans organizations, Fraternities, Historical groups, Motorcycle groups and Legislative groups. Consider the groups you belong to including clubs, churches, etc., and who in them may be eligible for VFW membership.

Wisconsin Veterans of Foreign Wars News **VOICE AND PEN** SEPT/0CT 2024 VFW Remembers the End of the Afghanistan War

It has been three years since the United States finally left Afghanistan in a calamitous and deadly withdrawal of our troops after almost two decades of war. Whether it is the footage of Afghan civilians clinging to the side of a C-17 Globemaster III and falling to their deaths or photos of the aftermath of the deadly attack at Abbey Gate which took the lives of 13 service men and women and more than 100 Afghans, these images from the chaos in Kabul at that time are seared into our collective memory. It is especially painful for those who fought so hard and for so long there. The frustration, the anger, the sadness, the sense of helplessness and hopelessness, and the never-ending question of "how could this of happened" all pile on to the moral injury many Afghanistan War Veterans experience as we observe the anniversary of the end of the conflict. As a Veteran of the Vietnam

War, I say to all of you struggling – you are not alone. I know exactly how you feel.

As I watched the video of the CH-47 Chinook helicopter landing on the roof of the U.S. Embassy in Kabul to evacuate diplomats and staff, it brought me right back to April 1975 and the images of evacuees boarding a helicopter just outside the U.S. Embassy in Saigon as the city fell to communist forces. After leaving my family behind, being wounded, losing friends, and fighting so hard for the Vietnamese people to maintain their freedom during my two tours of combat there, it felt like all of that was for nothing. That sinking feeling like you let your country down is a hard one to shake.

I'm here to tell you that, like me and my fellow Vietnam War Veterans, you have nothing to be ashamed of. You upheld the warrior ethos - you always placed the mission first, you never accepted defeat, you never quit, and you never left a fallen comrade. You took the fight to the enemy right where they were and for 20 years, you kept those terrorists from attacking our country like they did on 9/11. You successfully executed the largest non-combatant evacuation airlift in U.S. history. You did exactly what your country asked you to do and did it courageously with honor and dignity. Because of all of this, you can hold your head high. We are all so proud of you.

The question of why everything went down the way it did still needs to be answered, and of course this will take time. I'm glad that Congress saw to it to form a commission to do a deep dive into the Afghanistan War and get the answers we all deserve. I'm honored that the Veterans of Foreign Wars (VFW) Memorial Building was selected as the location for the inaugural meeting and that VFW Washington

Office staff were able to host the commissioners and witnesses for the hearing. You can read the Afghanistan War Commission first interim report here. Never again should we go to war without a clear path to victory and without our political leaders making the same sacrifices that they ask us to make.

On behalf of the more than 1.4 million members of the VFW and its Auxiliary, we ask all Americans in joining us in honoring the memory and sacrifice of the 2,459 brave Americans who died in service to a grateful nation, prosecuting Operations Enduring Freedom and Freedom's Sentinel for nearly 20 years in Afghanistan for each one of us. To those who came back, we say, "thank you," "welcome home" and "job well done."


LAST CALL for Voice and Pen!




The words we use are immensely important! Just as our nation was "spoken into existence" so too we must speak the words we need people to hear in order to manifest the reaction we want to see.

For expedience, more than anything else, we tend to shorten things or use acronyms. The acronyms, while accurate, don't pack the same punch as saying the entire word.

This year and going forward, I encourage you to use #MoreThan-Letters especially when referring to our POWs, MIAs and KIAs. They are more than letters.

Encourage the use of the words: Prisoner(s) of War, Missing in Action, Killed in Action.

- Acknowledge them daily
- Learn and say their names
- Have a dedication ceremony
- Host a special program
- Write about them in your newsletter
- Share their storie



• Meet their families

• If your state has a POW/MIA Day ceremony at the Capitol, GO! If it doesn't, start one.

Remember, not all of our treasured service members returned home from their duty protecting us and our way of life. So really, our celebration of other patriotic holidays (while important) would not be possible without those who put their lives on the line, who were taken prisoner, went missing in action, or who were killed in action defending and guarding the nation. We must all remember that and include an acknowledgment of them in every holiday observance.

savvy generation. The entire interaction can be quick and painless; AND it shows us to be modern and adaptable. Behind this QR code will be things like the Fact Sheet, Membership Application, What We Do, Auxiliary Locator and anything else we might need in our "Recruiting Tool Kit."

To use military terms: we are in a target-rich environment, so why aren't we hitting anything? If we embrace new techniques, we WILL be able to turn the membership tide and hopefully turn it into a tidal wave! *"From Our Roots to Our Branches, Extending Service to Our Veterans", we are "Honoring Veterans Together".*



Sgt. Jack Hohlfeld Laid to Rest at Last

As previewed in the July/August WI VFW NEWS, the remains of WWII Prisoner of War Sgt. Jack Hohlfeld were finally returned home to Wisconsin at the end of August, nearly 82 years after his death on December 26, 1942. Following the American surrender on the Bataan Peninsula in April 1942, he survived the brutal Bataan Death March, dying of pellagra eight months later in the notorious Cabanatuan Prison Camp. Buried with five others in Common Grave 811 at a local cemetery, it took until 2018 for the remains to be disinterred and sent to the Defense POW/MIA Accounting (DPAA) lab for analysis, with his positive identification finally announced on May 29 of this year.

After a well-attended and moving Funeral Mass at St. Patrick Parish in Onalaska, followed by burial with full military honors in the Catholic Cemetery in La Crosse, "Sgt. Jack" is home at last. After 82 years, more than 8,000 miles away, he is now at

rest, about 80 feet from his parents' graves. He is survived by niece Sharon (nee Hohlfeld) (Ron) Graw of Onalaska; a nephew Ron (Della) Hohlfeld of Flagstaff, AZ, and several great-nieces and nephews.




with plenty of room for a Bounce House, climbing wall and other outdoor games.

- Take a nice GROUP shot of all winners we probably don't have room for 3-6 photos from each event. And group them in a nice sitting/standing group - not spread out in one line!

• Action photos - doing, building, hauling, folding, saluting, etc. - create extra interest.

• Names (and titles) of those in the photo MUST accompany the photo submission. Period. List them left to right, by rows/seated/standing - whatever applies. Interesting details are a bonus!
